# DESCRIPTION OF SOME AREAS OF ACTIVITY



## Contracts

We assist clients in the **drafting of all types of contracts**, including: contracts for the construction of production facilities, contracts for the maintenance of hydroelectric power plants, contracts for the distribution of agricultural machinery or spare parts for agricultural machinery, agency contracts related to the promotion of the sale of sensors, rental contracts involving real estate for commercial or industrial use, general conditions for the sale including components for industrial automation, and intra-group contracts for the management of common services.



## Art Law

## Employment Law

## Company Law & M&A
